Dear Mr. William Rhodes:

The Division for Air Quality is preparing to assess the Air Emissions Fee for 2014. Your plant's **actual emissions totals** for SO<sub>2</sub>, NO<sub>2</sub>, VOC, and PM<sub>10</sub> data are shown on the enclosed **Acknowledgement Checklist**. These emissions have been calculated using 2013 data, which you submitted to this office using the DAQ Web Survey earlier this year. To obtain a printout of your plant's entire data, you must retrieve it from the DAQ Web Survey website. To access this report, go to DEP's web site (<https://dep.gateway.ky.gov/eportal>) and logon using your existing Logon ID and password. From the "DAQ Web Survey" tab, select your Agency Interest and the Survey Version "Accepted by DEP." Click "Facility General Report" to view, save or print a copy of the facility printout. No printout will be sent from this office.

The fee will be based on the **actual emissions total** for SO<sub>2</sub>, NO<sub>2</sub>, VOC, and PM<sub>10</sub>, as they appear on the enclosed Acknowledgement Checklist. If the actual emissions total for all four pollutants is greater than zero and less than 25 tons/year, the fee will be \$150. If the actual emissions total for these four pollutants equals or exceeds 25 tons/year, the per/ton rate will apply. The per/ton rate for 2014 will be determined once any changes resulting from these emission statements have been made. There will be no fee assessed this year for plants where the actual and potential emission totals for each pollutant is less than ten tons. The fee is assessed on plants that qualify as Title V major sources or sources subject to a federal requirement. Specifically, there will be no fee assessed this year for plants that have been approved as "Conditional Major", "Minor", or "Registration", if the source is not subject to a federal requirement. However, these exemptions do not necessarily exempt those sources from any future billings by this Division.

Enclosed is a **CHECKLIST** for you to indicate if you **AGREE** or **DO NOT AGREE** with the **ACTUAL** emissions totals for SO<sub>2</sub>, NO<sub>2</sub>, VOC, and PM<sub>10</sub>. If you identify a problem with the emissions data, please indicate on the CHECKLIST, attach documentation, and return to me immediately. In accordance with regulation 401 KAR 50:038, this office must be notified of any error made in the determination of subject emissions within 30 days of the date of this letter, in order to have any changes in the subject emissions considered. **Responses are due by July 23, 2014.**
